When using an **IPM** approach, Pest populations are maintained below economically damaging or socially unacceptable levels. All practical measures to suppress the Pest population to a tolerable level are considered: These include cultural controls (e.g., changes in maintenance practices, regular cleaning schedule, garbage elimination, changes in worker procedures) Pest exclusion, physical modifications (e.g., screening, caulking, etc.), pest control devices and pesticides. Using a combination of these cultural, physical, biological and chemical control techniques to minimize adverse effects to the public or the environment.

SANITATION AND PROOFING

Sanitation is a key component to the success of any **IPM** program. The structural pest control applicator must educate the client on the importance of maintaining a high level of cleanliness both inside and outside a structure. By maintaining a clean environment, pests may be eliminated. Sanitation practices may include routine and “special” cleaning, review and improvement of waste management practices and management or packing materials such as cardboard boxes.

Before **Verminex** carries out the service in any property we have to make sure that the facility is properly ready for undertaken our Pest Control Services. Sanitation is the most significant potential to keep the property free from any pest infestation and sound harborage. Hence **Verminex** gives more firm direction to uphold the environmentally hygienic condition in all-weather as well as throughout the year. Similarly, **Verminex** will personally organize with you to undertake an overall evaluation about the potential sanitation threats in all sensitive locations especially the food handling areas.

Waste Management Program is also a very seriously considered matter and a professional approach need to be arranged for the disposal and removing on a regular interval, especially the unwanted food as well as non-food stuffs. Reviewing the housekeeping activities, a planned schedule is recommended to keep up the property as a pest free zone. Unless serious precautions given to pest harborage and hatching will be multiplied within a due course. Housekeeping activities need to be intensified in all hidden and unattended areas otherwise the dark and undisturbed places will surely provide conducive condition for the nuisance pests to thrive on.

GENERAL PEST ABATEMENT

We spotlight on the target pests like rodent (Rat and Mice), crawling insects like (Cockroaches, Ants, Spiders, Scorpion etc.), Bed bugs, Flies, Mosquitoes, etc. and execute our professional style of treatment for the abolition of the threat. Residual insecticides treatment will be carried out and is highly effective in the eradication of vermin's, immigrant's insects and the successive generation. One application will remain for a long period to months, therefore killing insects that come into contact with the treated surfaces (e.g. Roaches, Ants, Bugs, etc.). Odor & Odorless chemical will be used for this propose. Gel application also will be done for sensitive areas.



RODENT ABATEMENT

VermineX will make available Bait stations on demand to extrude the threat of Rat and Mice from your facility. The exterior perimeter of the facility shall be placed with steel or metal traps, and microencapsulated baits etc. to avoid the entry of the rodents into the facility. We will give site map and the action plan for the abolition of rodent issue from your property. On the light of the inspection we shall place microencapsulated baits as well as the glue traps, pads, stickers etc. to eliminate the rodent issue from your properly. Similarly, if any rat is either trapped or found dead after consuming the baits we will be so vigilant to replace the taps and remove the dangerous pest from your facility the same day itself. Our systematic operation is going in an unbreakable style. Tamper resistant bait stations shall be positioned as per the recommended distance and secured them with location map for monitoring and replacing them on an easy manner. Similarly, an inspection tag or sticker also attached with them for making sure the nest regular visit easier.



A NOTE ON PESTICIDE RESISTANCE:

Repeated applications of the same pesticide or chemically similar pesticides over time can lead to the buildup of resistance. When this occurs the most complete application cannot achieve acceptable control. With repeated applications after population recovery, the more susceptible individuals are killed and those that are less susceptible become the parents of the next generation. Alternating pesticides with different modes of action (E.g., organophosphates and pyrethroids) and of different types (e.g. baits) can also be helpful. Of the urban Pests, the house fly and the German cockroach lead in the development of resistance to pesticides. The use of an integrated approach to pest management reduces reliance on individual pesticides can help slow or prevent the development of resistant pest populations.
